 All natural stone, grout, ceramic tile, porcelain tile, terra cotta, Saltillo and other water-safe surfaces such as tubs, sinks and glass

# **LIMITATIONS**

- Ensure that product does not come in contact with any non-recommended surface.
- Do not use over painted surfaces.
- Do not mix with other chemicals.

#### **INSTRUCTIONS**

Note: Choose all appropriate safety equipment before use. Refer to the Material Safety Data Sheet (MSDS) for more information.

# Always test first in several inconspicuous areas to confirm desired results.

- 1. Spray directly on the area to be cleaned from 5" to 7" (12,5 to 17,5 cm) away.
- 2. Scrub the surface using a brush, white nylon pad, sponge or cloth.
- 3. Wipe dry using a soft cloth, microfiber cloth or sponge.
- Use clean water to rinse all surfaces that come into direct contact with food
- 5. In the case of tough dirt, allow the product to stand for several minutes before scrubbing.

Close container tightly after each use. Store in original container only. Store between temperatures of 35°F to 90°F (2°C to 32°C). Do not allow to freeze.

**HANDLING PROCEDURES** – Do not get in eyes. Keep out of the reach of children. Wear suitable protective clothing and eye/face protection. Store in a cool, dry, well-ventilated area. Never pour unused product back into the original container. Always dispose of properly and in accordance with local, state and federal guidelines.

FIRST AID TREATMENT – EYES: If in eyes, rinse with water for 15 minutes. If irritation persists, get medical attention. **SKIN**: If on skin, rinse well with water. If irritation persists, get medical attention. **INHALATION**: Immediately remove the affected person to fresh air. **INGESTION**: Flush out mouth with water. If swallowed, call a poison control center or doctor immediately. Do not induce vomiting.
